**ORDER GRANTING RECEIVER'S MOTION FOR AUTHORITY TO SELL
CERTAIN OIL AND GAS PROPERTIES OF THE RECEIVERSHIP ESTATE**

The Receiver's Motion for Authority to Sell Certain Oil and Gas Properties of the Receivership Estate filed herein on September 24, 2008 (the "Motion"), comes on before the Court for hearing this 30th day of October, 2008. The Court finds that the Motion should be granted.

IT IS THEREFORE ORDERED ADJUDGED AND DECREED that the Motion is granted and approved. The Receiver is authorized to sell any oil and gas properties that are: (a) owned by Powder River Petroleum International, Inc. or any of its affiliates (the "Company"), or (b) otherwise part of this Receivership Estate including, but not limited to, those properties listed on Exhibit "B" to the Motion. The Receiver is authorized to sell such



The Receiver is further authorized to execute and deliver any documents on behalf of the Company or the Receivership Estate that may be necessary in his judgment to consummate any sale of the oil and gas properties.






